IN THE CLARK COUNTY MUNICIPAL COURT ON THE ____ DAY OF _____, 20____,

(THE DEFENDANT) DOES APPEAR IN FRONT OF THE CLERK AFTER BEING SERVED A CITATION FOR DISTRACTED DRIVING, IN VIOLATION OF 4511.204 OF THE OHIO REVISED CODE, AND WITH THIS BEING THE FIRST VIOLATION WITHIN TWO YEARS, THE DEFENDANT MAY:

- 1) ____ REQUEST NINETY (90) DAYS TO COMPLETE THE BUREAU OF MOTOR VEHICLES ONLINE DRIVING COURSE, AS DESCRIBED IN 4511.991 OF THE REVISED CODE. IF THE DEFENDANT SUCCESSFULLY COMPLETES THE COURSE, THE DEFENDANT SHALL BE ISSUED WRITTEN EVIDENCE THAT THEY SUCCESSFULLY COMPLETED THE COURSE. UPON PRESENTATION OF THE EVIDENCE TO THIS COURT THE DEFENDANT SHALL NOT BE REQUIRED TO PAY THE FINE AND SHALL NOT HAVE THE POINTS ASSESSED AGAINST THEIR DRIVERS LICENSE, HOWEVER THE DEFENDANT WILL STILL BE RESPONSIBLE FOR THE COSTS OF THE CASE. THE DEFENDANT SHALL HAVE UNTIL THE ____ DAY OF _____, 20____, TO BRING THE CERTIFICATE OF COMPLETION TO THIS COURT.

- 2) ____ WAIVE THE OPTION TO COMPLETE THE BUREAU OF MOTOR VEHICLES ONLINE DRIVING COURSE, AS DESCRIBED IN 4511.991 OF THE REVISED CODE, WHICH IS OFFERED TO FIRST TIME OFFENDERS WITHIN TWO YEARS. THE DEFENDANT WILL BE ASSESSED THE FINE AND COURT COSTS AS SET BY THE CLARK COUNTY MUNICIPAL COURT AND POINTS AS SET BY THE BUREAU OF MOTOR VEHICLES.
